1. The Executive Officer, Notified Area Council, Nimapara invites sealed tenders in conformity with detailed tender call notice to be eventually drawn in contract from F2 for the following works from eligible registered contactors of this N.A.C. & all the state Govt. registered contractors who have D & C Class Licence.
2. Bid documents containing plans, specifications, the schedule of quantities & terms & conditions of contract and other necessary documents can be availed from the office of the Notified Area Council, Nimapara during office hours every day except on Sundays and Public Holidays till last date of sale and receipt of tender papers.
3. While tendering a bid must be accompanied by the Earnest money 1% of the amount specified for the above work shown in the table appended herewith in shape of T.D.R./K.V.P./N.S.C./PO TD etc duly pledged in favour of the Executive Officer, N.A.C. Nimapara at the time of tendering.
4. The sale and receipt of documents shall start from **Dt.29.01.2026** and will close on **Dt.06.02.2026 up to 5 P.M.** during working days.
5. Bid must be delivered in the bid box kept in the office room of the N.A.C. for the purpose.
6. Bid documents can be purchased from the office of the undersigned against a nonrefundable cost of the documents as indicated in the form in cash only.
7. Bid documents requested by mail will be dispatched by registered post/Speed post on payment of an extra amount of Rs. 100.00 (One hundred) only over the cost of tendered documents. The Executive Officer will not be responsible for the postal delay if any in the delivery of the documents.
8. The bid will be opened on **Dt.07.02.2026 at 11.00 A.M.** in the N.A.C. Office in the presence of the bidders or authorized agent who wish to attend. If the office happens to be closed on the last date of receipt of the bids as specified, the last date of receipt will be extended by the days of closure of office and will be opened on the next office day at the same time and venue.
9. The bidders are required to furnish the attested photo copy of Valid Registration Certificate, GST Clearance certificate, PAN Cards & Labour Licence along with the Bid documents, otherwise the bid shall be declared as non-responsive and thus liable for rejection.
10. Cash receipt against purchase of tender paper will be issued without mentioning the name of the contractor but with mention of the work for which purchase has been made.

11. The tenders are required to execute the work as approved specification.
12. Other details can be seen from the bidding documents.
13. The bidders will make at his own cost at the site for the proper storage of the materials.
14. The bidders will make at his own cost to engage labourer as per the direction of the Govt. from time to time & will arrange medical Aid & other Aid facilities to them.
15. No extension of time will be allowed to complete the work without any sufficient reason as per request of the bidders & will execute the agreement with the undersigned as per the terms & conditions of N.A.C. Nimapara before starting of the work.
16. No compensation will be paid to the executants or his associates for any loss of human life or others during Natural Calamity or any other mishap.
17. No excess rate quoted by the bidders over the estimated cost of the work will be allowed.
18. Any other terms & conditions as per the O.P.W.D. Code & instructions/directions issued by the state Govt. from time to time will be strictly followed.
19. Payment will be made subject to availability of funds.
20. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
21. All projects shall be implemented with mandatory O & M period of at least 3 years for all assets created during the current financial year. The high value assets depending on their type and usage, a minimum 3 years O&M clause shall be included in the tender documents as an integral part of the DPR to ensure periodic upkeep and long term sustainability.
